The regular fourth Monday of the month meeting of the Harveysburg Village Council was held pursuant to call, upon, the proper notice to the public, on March 26, 2018 at 7:07 PM at the Harveysburg Village Government Center, 79 West Main St., Harveysburg, OH 45032.

The meeting was called to order by Mayor Verga, followed by the Pledge of Allegiance and a Moment of Silence.

MINUTES

MAYOR'S REPORT

A resident on Maple St. with goats, a pig and a yard full of debris is in violation of the Zoning Code – Mayor Verga instructed Chief Pottenger to issue a 10-day clean-up order or face a court appearance. The Township Easter egg hunt and pancake breakfast will be on Saturday, March 31, 2018. The swimming season is rapidly approaching and emphasized the need for water safety, Zoning Code and property protection priorities. The Mayor cautioned about mowing and discharging clippings into the streets and ultimately into the sewer system.

VILLAGE SOLICITOR REPORT & ORDINANCE READING

Solicitor Lucas reread Resolution R-2018-004 for a third reading. This resolution covers the updated/revised *Policy for Purchasing Procedures*. After the third reading, Mr. Bennett moved, and Mr. Carruthers 2nd. to approve the ordinance. Chief Pottenger reported on the status of car #2 and the recovery of funds from State Farm Insurance Co – Sean Meier's insurance coverage. The Fiscal Officer deposited a check for 1,820.47 from State Farm Insurance Co. Chief Pottenger continuing his report included his desire to have a second cruiser available, suggesting a possible lease-purchase. Discussions followed. The Chief will gather details and dollar amounts and report back to council. Mr. Cochran moved, Mr. Nelson 2nd. By a voice vote all members voted yea.

Mr. Bennett moved to adopt a resolution moving the insurance claim proceeds from the general funds to police funds and designate the funds as monies towards the Village's portion of the grant match, Mr. Cochran 2nd. A roll call vote followed: Mr. Bennett, Mr. Carruthers, Mr. Cochran, Mr. Juniel, Mr. Nelson and Mr. Rhoads voted aye. Motion passed. The resolution is being prepared for signatures.

Chief Pottenger presented to Council his need for a second police cruiser and outlined the research for a lease/purchase type acquisition. After much discussion and the need for more information Mr. Cochran moved, Mr. Nelson 2nd. to table the proposal until April 9, 2018. A roll call vote followed: Mr. Bennett, Mr. Carruthers, Mr. Cochran, Mr. Juniel, Mr. Nelson and Mr. Rhoads all voted yea, motion passed.

The finance committee met this evening at 6:00 PM. Fiscal Officer Faulkner presented the 2018 final appropriations for the budget. After discussions, Mr. Bennett moved, Mr. Cochran 2nd. to approve the final appropriations. Roll-call vote: Mr. Bennett, Mr. Carruthers, Mr. Cochran, Mr. Juniel, Mr. Nelson and Mr. Rhoads voted aye. Motion approved. Faulkner reviewed the continuing struggles and issues with the local bank. Faulkner asked for permission to talk with other banks, council approved. Last item, Faulkner forwarded the presentation to the finance committee commending the work of the Clerk-of-Courts and her hourly compensation rate. He recommended a \$1.50/hr. raise. After council's discussions, Mr. Cochran moved, Mr. Juniel 2nd. to approve a 1.00/hr. raise and allow Mr. Trimble to add a merit increase after a review. Roll call vote followed: Mr. Bennett, Mr. Carruthers, Mr. Cochran, Mr. Juniel, Mr. Nelson and Mr. Rhoads all voted aye. Motion approved.

The Grant Committee scheduled a meeting for March 20th. Their agenda included the police vehicle grant, searching for grants, and a state program CORF – to remove/teardown old structures.
