Mark Tipton, President of Council, calls the meeting to order at 9:00pm.

**Meeting Purpose:**

The need for the emergency meeting is to discuss the resolutions for the general operating levy that have been previously discussed in council meeting but need to be corrected due to a scrivener’s error on the previous levies and there is an imminent deadline.

Mr. Tipton reads Resolution 2022-017. Proposing a renewal levy plus increase for the general operating levy as set out in ORC 5705.19(A) to be submitted to the electors.

Motion made by Mr. Bennett to declare Resolution 2022-017 an emergency and to waive the three readings. Second by Mr. Juniel. Roll Call vote: Aye - Bennett, Juniel, Nelson,

Motion made by Mr. Bennett to pass Resolution 2022-017. Second by Mr. Juniel. Roll Call vote: Aye - Bennett, Juniel, Nelson, Herberth, Tipton. Nay – None. Motion passed. Herberth, Tipton. Nay – None. Motion passed.

Mr. Tipton reads Resolution 2022-018. Proposing a renewal levy plus increase for the general operating levy as set out in ORC 5705.19(A) to be submitted to the electors. During the reading, an error is found in Section 3. Note is made to correct the wording.

The incorrect verbiage: “which amounts to \$0.30 for each one hundred thousand dollars”.  
The corrected verbiage: “which amounts to \$0.30 for each one hundred dollars”.
