Chairwoman Kim Herberth called the meeting to order at 6:30pm.

Motion made by Mr. Juniel to excuse Leroy Sanders. Second by Chief Pottenger. Vote – Herberth, Juniel, Pottenger, Trovillo, Mayor Verga – Aye / Nay – None. Motion passed.

Motion made by Mr. Juniel to approve February 13<sup>th</sup> minutes. Second by Mr. Tipton. Vote – Herberth, Juniel, Pottenger, Trovillo, Mayor Verga – Aye / Nay – None. Motion passed.

## Harveysburg PD report: Chief Pottenger

Chief Pottenger begins his report:

- Both vehicles are running well.
- There was a domestic violence call that was handled by the Sheriff's office. There was an arrest made.
- He checked with other departments at the Chiefs meeting and no other departments needed to combine OBC book orders.

- One applicant will be interviewed on Friday.
- LEADS audit is taking place. There is one item that needs to be addressed and then everything should be complete.
- OPOTA has released the second of three mandatory classes. Chief Pottenger will be attending a Deescalation Course tomorrow.
- Due to health problems with Officer Kiser's family, it will be a couple weeks before he is released on his own.

Mr. Tipton asks what is involved in the LEADS audit. Chief Pottenger states it involves being up to date on policies and procedures. Joe Nelson needs to complete his LEADS training. Per LEADS, only someone who is LEADS certified or being escorted by someone LEADS certified is allowed to be in the main office due to LEADS information being available within the office.

Mr. Tipton asks if Chief Pottenger has received an update from Mr. Kirby on the settlement amount from insurance for the totaled cruiser. Chief Pottenger has not received an update.

Mayor Verga states he reported to Chief Pottenger that a car has been sitting in a cul-de-sac and has not been moved. He has received complaints from Bill when he is out plowing snow and from the trash company that the vehicle is blocking part of the roadway.

Mr. Tipton asks if Chief Pottenger has spoken with Mrs. Wilkie about the auxiliary title for officers. Chief Pottenger has not spoken with her yet.
