## Harveysburg PD report: Chief Pottenger

Chief Pottenger begins his report:

- -Vehicle #3 is officially totaled and has been placed in the garage so it can be stripped of all equipment and radios. Vehicle #2 was involved in a minor fender bender on October 29<sup>th</sup>.
- -Next local event will be the Christmas party on December 9<sup>th</sup>.
- -Still citing speeds over 70mph on SR 73.
- -We are working on grants for equipment.
- -We are looking for officers, but like many local agencies, having a hard time finding applicants.

-The Halloween party went well, and we had approximately 80 children attend. Trick or treating also went well and traffic was managed for the safety of those out that night.

Mr. Tipton asks if we are going to get a Renaissance Festival reimbursement for our car hours. Chief Pottenger states he did not have cars working the festival except when they stopped to help with calls or traffic backups.

Mr. Tipton asks if the OneClaim Program was completed. Chief Pottenger states he did not get registered in time. He has been put on the list to be notified for next years class.

Mr. Tipton asks how many incidents Harveysburg PD handled at the Renaissance Festival. Chief Pottenger states there were probably 8-10 that the patrol car came as backup. Mr. Tipton asks for case numbers of those incidents.

Mr. Tipton asks how many car accidents occurred during the Renaissance Festvial. Chief Pottenger believes there were 3, but they were handled by OSP or the Sheriff's Department.

Mr. Tipton asks if the officer schedules are available for November and December. Chief Pottenger has the schedule for November.

Mr. Tipton states we need to have the fishing derby items removed from the gym in preparation for the Christmas party. Chief Pottenger says he will get everything out and moved to the donated storage area at Clabo's.
