The regular second Monday of the month meeting of the Harveysburg Village Council was held pursuant to call, upon the proper notice to the public, on December 09, 2019 at 7:00 pm at the Harveysburg Village Government Center, 79 West Main Street, Harveysburg, Ohio 45032.

ROLL CALL: Council members- Mr.Cochran, Mr. Bennett, Mr. Nelson, Mr.Carruthers, Mr. Rhoads, Mr. Juniel- members responding here. Village Staff: Village Administrator – Donald Fugate, Clerk of council - Vicki Draginoff, and Village Solicitor – Joe Lucas.

The meeting was call to order by Mayor Verga at 7:03 pm, followed by the National Anthem, Pledge of Allegiance, and a moment of silence.

Motion to accept approval of minutes for November 25th, 2019, motion made by Mr.Bennett, 2nd Mr.Juniel, Roll call- Mr. Cochran, Mr. Bennett, Mr. Nelson, Mr.Carruthers, Mr. Rhoads, Mr.Juniel- All members voted yea. Motion approved.

MAYOR'S REPORT

Township trustee meeting was the shortest meeting since the weather was so cold inside and out, it lasted 23 minutes.

Fridays Christmas party turnout was great, we gave out 3 hero awards; Rigsby's showed up and brought their dog that was lost in the car wreck and presented awards to the Village.

Annexation paperwork is still in township lawyers hands.

Front door project looks like we will pay \$1.00 a year to lease the property.

When we swear in new officials we have never had a copy of the Ohio Constitution and copy of Constitution of the United States so Mayor Verga had requested the office find a copy and post it up in the hallway of the town hall or office walls. Village office has found parchment copies and have available now.

VILLAGE ADMINISTRATOR / STREETS & BUILDINGS REPORT

Trees on Main Street have been planted.

1 hour OSHA BIO Hazard online safety class and a 10 hour OSHA construction safety course has been completed by Joe Nelson and Bill Hubble in the service dept.

Salt spreader has been repaired and cleaned off after every use already and will be in the future cleaned every time it is used.

Bathroom condensation in ladies restroom has been repaired.

VILLAGE SOLICITATOR REPORT

Mr. Lucas suggested we have a master calendar for all payments due; levy's and taxes so we are not missing out on anything like we did for 2019.

Mr. Lucas read Resolution 2019-068 Temp Appropriations and resolution was adopted as stated above the Fiscal Officer report. 2019-068 3 readings were waived and resolution was adopted.

Mr. Lucas read resolution 2019-069, proceeding with the addition of the operating levy, motion waive 3 readings was made by Mr.Bennett, 2nd by Mr. Juniel
