The regular second Monday of the month meeting of the Harveysburg Village Council was held pursuant to call, upon the proper notice to the public, on May 11th 2020, 7:00 pm at the Harveysburg Village Government Center, 79 West Main Street, Harveysburg, Ohio 45032.

ROLL CALL: Council members- Mr.Cochran, Mr. Bennett, Mr. Nelson, Mr.Carruthers - members responding here. Village Staff: Village Administrator – Donald Fugate, Clerk of council - Vicki Draginoff, Fiscal officer-Mary Wilke Police Chief Richard Pottenger.

The meeting was call to order by Mayor Verga at 7:06pm, followed by the National Anthem, Pledge of Allegiance, and a moment of silence.

PRO TEM REPORT

Mark Tipton- Spoke on the opportunity to go after expenses during the Covid 19, Mr.Tipton asked us to make sure we are keeping all the receipts during this time.

VILLAGE ADMINISTRATOR / STREETS & BUILDINGS REPORT

Water hole has been fixed in service barn.

Nathan came back to work as third servicemen for the village; he also received a \$1.00 raise.

Mr. Fugate also reported elections will do an automatic recount with results available on Thursday.

FISCAL OFFICER REPORT

We spoke on audit costs being \$16,236, they have been sending over lists of requests. Don and Vicki have been supplying supporting documentation. Audit is being done remotely and we are scanning docs to them to review. We currently had \$3,749 in this line item and would like to add a buffer of 13,000 to the appropriations for audit services. Copies of appropriations have been given to council.

We reviewed placing funds in the Ohio Treasurer of States STAR account. Mrs. Wilke stated she would need a resolution to approve this.

Mrs.Wilke also stated we are up for renewal with LCNB; they presented a 5yr renewal which is typical with same terms although we can do a 2 yr. renewal.

She reviewed the bank fees and they are high and that is why the consideration for doing a 2 yr. renewal is on the table.

Motion to accept the LCNB renewal of 2yrs, motion made Mr.Bennett, 2nd by Mr.Cochran Motion approved, all in favor

Finance committee needs to meet this month to start preparing the 2021 budget, will need final approval in July.

I did not know about the street lights- I do not believe I appropriate monies for this.

Mr.Cochran made a motion to waive the 3 readings for adding \$13,000 to audit budget, 2nd by Mr.Carruthers. All in favor. Motion passed.
