Phil Trovillo called the meeting to order at 6:00pm.

Roll Call: Tipton, Juniel, Mayor Verga, Trovillo

Motion made by Mr. Juniel to excuse Mr. Sanders. Second by Mr. Tipton. Vote – Trovillo, Tipton, Juniel, Mayor Verga – Aye / Nay – None. Motion passed.

Motion made by Mr. Juniel to approve the March 13th minutes as written. Second by Mr. Tipton. Vote – Trovillo, Tipton, Juniel, Mayor Verga – Aye / Nay – None. Motion passed.

Mr. Trovillo states the old truck was not taken in for work.

Mr. Trovillo reports that Bill has been trying a new cold patch that is cheaper and it has been doing well holding up so far. He adds that North Street was inspected, and the size of the pothole was exaggerated.

Mr. Trovillo reports that Bill has begun mowing around the Village.

Mr. Trovillo reports that kids are trying to swim in the lake by the pump house. The police made contact and asked them to leave, but they quickly came back once the police officer left the area. He states it is extremely dangerous to swim there and we have had one fatality before.

Mr. Tipton asks if we have thought about renting a stump grinder. Mr. Trovillo has not looked into rentals.

Mr. Trovillo states the tree by the post office needs to be removed.

Mayor Verga states he spoke with a realtor office in Texas that inquired about the 2.5 acres for sale on Old 73 for the purpose of building a Dollar General. Mr. Tipton reports that the easement along that property was vacated years before and makes that property landlocked. Any buyer would need permission to access the road from the owners of the easement.

Mr. Trovillo states trees are starting to grow into the power lines and need to be cut back.

Mr. Trovillo states Bill is looking for scrap metal to build things with. Mr. Tipton will inquire at a business that often has scrap metal.

Motion made by Mr. Tipton to adjourn at 6:23pm. Second by Mr. Juniel. All Aye.
