This is a summary of the meeting of the Harveysburg Streets & Buildings Committee held August 8, 2022, at 6:00 PM. Upon request, a recording of the meeting is available for review.

Chairman Phil Trovillo called the meeting to order at 6:36pm.

Roll Call: Trovillo, Tipton, Juniel, Mayor Verga

Motion made by Mr. Tipton to excuse Leroy Sanders. Second by Mr. Juniel. Vote – Juniel, Tipton, Trovillo – Aye, Nay – None. Motion passed.

Mr. Tipton reports that the lift rental will be approximately \$250/day plus \$110 delivery and pickup fee. The price varies slightly depending on the company we go with. We will have to decide if we will rent for a couple days or rent the whole week. Once you reach 3 days it is more cost efficient to rent for the whole week. The lifts have a 500lb capacity.

Mr. Trovillo states that we should look into the possibility of moving the A/C units so that they are easier to access and maintain in the future.

Mr. Tipton states he is looking at the first week of October to rent the lift and get the A/C units fixed and the LED lights installed. If time allows, we should also do some basic maintenance of the gym such as new paint, fixing the noise suppression carpet back into place and removing the scoreboard.

Mr. Tipton states that the lights will be installed by Mockbee out of Cincinnati.

Mr. Tipton states that he would like to get an AED for the building. With as many activities as we have held in the building it would be an asset to have in an emergency. They cost approximately \$2,500/device. The grant he applied for to receive the AEDs was denied.

Mr. Trovillo states the new plow truck needs strobe lights installed, we need a salt box, and he would like to upgrade the front-end suspension. We have also not received the blade shield we paid for yet.

Chief Pottenger reports that he was told one of the backboards is broken in the gym, but he hasn't had the chance to look at it himself yet.

Mr. Trovillo states the Bill has trimmed the trees back quite a bit. He states that there is one dead tree that needs to be removed before a storm brings it down. He also states the Maple trees are up into the powerlines.

Mr. Juniel states that the property at 32 South St. needs mowed and Mr. Trovillo states the Burton properties need mowed.

Motion made by Mr. Juniel to adjourn at 6:55pm. Second by Mr. Tipton. All Aye.
