The regular second Monday of the month meeting of the Harveysburg Village Council was held pursuant to call, upon the proper notice to the public, on April 8th 2021, 7:00 pm at the Harveysburg Village Government Center, 79 West Main Street, Harveysburg, Ohio 45032.

#### MAYORS REPORT

Project will begin again with Jones Warner on Ken & Loraine May 1<sup>st</sup>. Mayor Verga also informed council of the questions that the corp is asking on the front door project. They wanted details of the flooring and placement and Mayor was not ready to provide that info.

Historical society wants to put a visiting center next to Black school. Matching grant is \$160,000, great is \$320,000. Building would be for events and meetings.

Mayor also informed council of the Ohio Municipal league – All municipalities under 50k will receive funding-we have not heard yet of the 111,000-1/2 given to us by June 1<sup>st</sup> and other half by end of year.

Supreme Court reports issue has been resolved, technical glitch caused interruption in submission.
